PARCEL 2

Beginning for the same at a pipe, heretofore set on the Southwesterly side of McNabbs Lane (10' wide) at its intersection with the line of division between lots designated as 12 and 13 of subdivision labeled "Water Oak Point" recorded among the Land Records of Anne Arundel County in Plat Book 14, page 32; thence running with McNabbs Lane 1) South 51 degrees 30 minutes 00 seconds East 48.11 feet to intersect a stone, heretofore set at the end of the line of division between lots designated as 12 and 11 on the aforesaid Plat; thence, leaving said McNabbs Lane and running with and binding on said line division 2) South 32 degrees 50 minutes 01 seconds West 159.51 feet to a pipe now set on the Northeasternmost side of a 10 foot road unimproved thence with said road 3) North 51 degrees 30 minutes 00 seconds West 48.11 feet to a pipe, heretofore set at the end of the division between said lots 12 and 13 thence with said line of division 4) North 32 degrees 50 minutes 01 seconds East 159.91 feet to the place of beginning. Containing 0.17 acres of land, more or less. **TERMS OF SALE:** A cash deposit or certified check for \$25,000.00 required of the purchaser at the time of sale, balance in cash, certified check or cashier's check at settlement, which must occur within ten (10) days following final ratification of sale by the Circuit Court for Anne Arundel County, unless said period is extended by the Substitute Trustees, their successors or assigns, in their sole discretion, time being of the essence. Interest to be paid on the unpaid purchase price at the rate of 4.25% per annum from the date of sale to date of settlement. In the event purchaser fails to proceed to settlement as required herein, in addition to any other legal or equitable remedies available to them, the Substitute Trustees may, without further order of the court, declare the aforementioned deposit forfeited and resell the property at the purchaser's risk and expense. In such event, the defaulting purchaser shall be liable for the payment of any deficiency in the purchase price, all costs and expenses of both sales, reasonable attorneys' fees, all other charges due, and incidental damages. Taxes and water rent to be adjusted to date of sale.
