Registration for this sale and inspection of the vehicles being offered commences at 7:00 AM. The "Public Sale" consists primarily of bank and credit union repossessed vehicles and will begin at 8:00 AM. **Public buyers only have access to bidding on vehicles presented on the "public list" provided;** any vehicle not presented on the list for public buyers are for vehicle dealer purchases only.

**If you are planning to attend the sale to purchase a vehicle, you must register as a bidder before you may participate in the sale. A \$1,000.00 fully refundable safety cash deposit is required to obtain a bidder's badge for the sale.** An additional \$1,000.00 must be provided for each vehicle the bidder plans on purchasing. If you are the successful bidder on a vehicle, your deposit will be applied towards the sale price of the vehicle you purchased. **In the event that you fail to complete payment for the purchase of the vehicle, leave the sale without paying for the vehicle, or fail to deliver the full purchase price (and any applicable fees), the vehicle will be resold, and you will be responsible for any deficiency remaining after your deposit has been applied. Any deficiency in balances remaining open after thirty (30) days of the date of the auction sale may be referred for collection. All costs of collection, including attorney, court, service fees, etc. shall be the responsibility of you, the purchaser.**

**If successful in winning the bid, you will have until 4:00 PM the day of the sale to complete the transaction and pay in full; or you will forfeit your deposit.** There will be a buyers fee added to the price of the vehicle you purchase which varies per lane and is not disclosed before the sale takes place. **Acceptable forms of payment are cash, a bank cashier's check, or you may wire the money.** If you choose to wire the funds, please see a BSC employee for further information.

**If the public buyer refuses to pay for the vehicle(s) the auction has the right to withhold the \$1,000.00 (or more) deposit, or, at the auction's sole election, resell the vehicle and pursue collection for any deficiency balance remaining after application of your deposit, as provided above.**

**If you do not purchase a vehicle on sale day, your safety cash deposit will be returned to you in the full amount before you leave the auction.** If registered bidders leave without retrieving the \$1,000.00 deposit, a check will be mailed to you for the full amount within ten (10) business days

**Registered bidders are permitted to bring 1 guest into the auction and the person registering must provide a valid US driver's license.** No person under the age of 18 is permitted to attend the sale or to bid on vehicles. All attendees must have a valid form of US identification. Accepted forms of identification for guests include US driver's licenses, US State ID's, US passports, US military ID's, and federal ID's.

Note: Management of the Auction has the authority to refuse registration of individuals at the sole discretion of the Auction based on the Auctions' receipt of information it deems responsible.

**All the vehicles offered for sale in our public auction are sold "as-is" – with no warranty expressed or implied.** Therefore, bidders should be knowledgeable enough to determine the condition of the vehicles being offered since all sales are binding and final! **There shall be no arbitration of the sale.**
